JOINT STATUS REPORT ON CRIMINAL PROCEEDINGS AGAINST MR. JENSEN IN STATE COURT

Pursuant to the Court's April 24, 2025 Status Report Order, Plaintiffs Bridger Lee Jensen, Singularism, and Psyche Healing and Bridging LLC dba Psychedelic Therapy Journey, jointly with Defendants Utah County, Provo City, and Jeffrey Gray, provide the Court with a status update informing the Court of the status of the criminal proceedings against Mr. Jensen in state court, as follows. On December 18, 2024, the Utah County Attorney's Office charged Mr. Jensen with one count of Possession of a Controlled Substance with Intent to Distribute (psilocyn), a Second Degree Felony; one count of Possession or Use of a Controlled Substance (THC), a Class B Misdemeanor; and one count of Use or Possession of Drug Paraphernalia, a Class B Misdemeanor. These charges remain part of an active criminal case in the Fourth Judicial District Court in and for Utah County, State of Utah, Case No. 241404407. A copy of the docket from that proceeding is attached as Exhibit A.

On February 3, 2025, Mr. Jensen appeared for his Initial Appearance, where he waived reading of the Information, was advised of his charges and potential penalties, entered a not guilty plea, and set the matter over for a waiver hearing. On March 13, 2025, one of the lawyers for Mr. Jensen withdrew from the case. At the waiver hearing on March 17, 2025, the parties requested and received a continuance of the waiver hearing to May 19, 2025. Presently, the case is set for that waiver hearing on May 19, 2025 in front of Judge Sean M. Petersen.
